Summary of key activities

A. The Council approved a new award, the Graduate Certificate in Education and Theology, to be offered by Australian Lutheran College from Semester 1, 2020. The award supports participants to develop a critical appreciation of the Christian faith and its implications for their work in a faith-based education context. It aims to enhance the theological and spiritual awareness of those whose vocation is education, facilitating use of reflective practices to apply foundational knowledge and engage in the conversation between education and theology.

It applies to all relevant research conducted by the University's academic staff and honorary researchers and to research projects undertaken by candidates for degrees and other awards of the University.
- 2.1.2 Fair Treatment Policy and Safeguarding Policy: These are new policies that have been developed as part of the Conduct and Misconduct Framework which supports the new Code of Conduct. These policies will be launched as part of the Conduct and Misconduct Framework suite in July 2019.
- 2.1.3 *Media Relations Policy:* This revised policy provides direction to members of the University when engaging with media representatives or utilising media channels.
- 2.2 On 14 April 2019 the Academic Board approved the following policies:
- 2.2.1 *Student Progress Policy*: The previous Course Progress Policy has been revised and renamed the Student Progress Policy.
- 2.2.2 Academic Staff Policy: 4.3.A.2 and 4.3.B.2 of this policy have been amended to ensure that research is appropriately recognised, and that peer-reviewed research receives appropriate weighting.
- 2.2.3 *Minor Thesis Policy*: A minor amendment has been made to this policy at 10.5 a); 'failed by both examiners' has been amended to 'failed by two examiners'.
