This Gazette is a public document and is circulated to members of Council, members of Academic Board, University Executive, and Office of the Vice-Chancellor (OVC) Staff. It reports the outcomes of meetings of the University Council and Academic Board since the last Gazette was issued.

Summary of key activities

- A. A new website http://vox.divinity.edu.au has been launched to provide a one-stop shop which will be constantly updated with news, articles, opinion pieces and events from across the University and published by University staff and students. Members are encouraged to visit the website regularly and to submit content.
- **B.** Council approved the 2019 Schedule of Student Tuition Fees, incorporating a 2% increase on 2018 student tuition fees. <u>UD Tuition Fees 2019</u>
- C. The University Academic Calendar for 2019 2021 has been approved and is available on the University website at: Academic Calendar 2019-2021
- **D.** The Revd Dr Robert (Bob) Derrenbacker has been appointed Dean of Trinity College Theological School to commence in January 2019.
- E. The Senate of Catholic Theological College has reappointed Very Revd Associate Professor Shane Mackinlay to a further four-year term as Master of the College, commencing 1 January 2019. The Senate has also approved a period of study leave for him in first semester 2019, and has appointed Dr Frances Baker RSM as Acting Master during this time.

1. Regulations and Determinations

- 1.1 On 20 June 2018, Council approved amendments to the following Regulations: 4, 19, 20, 21, 24, 27, 32, 33, 34, 39, 42, 43, 45, 46, 47, 48, 49, 50, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 65, 66, 68, 69, 70, 71, 73, 74, 75, 76, 77, 78, 80, 81 with effect from 1 January 2019.
- 1.2 On 1 June 2018, the Academic Board approved amendments to Determinations to Regulations: 4, 19, 20, 21, 24, 27, 32, 33, 34, 39, 42, 43, 45, 46, 47, 48, 49, 50, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 65, 66, 68, 69, 70, 71, 73, 74, 75, 76, 78, 80, 81 with effect from 1 January 2019.

These amendments to the Regulations and Determinations implement a new points system to denote the weighting of units in all University awards. This system will take effect on 1 January 2019. The changes do not affect the workload or student tuition fees required for University awards. The new system means that:

- a full-time year of study will be 144 points
- a full-time semester (half-year) will be 72 points

- a standard postgraduate unit will be 24 points (1/6 of a full-time year)
- a standard undergraduate unit will be 18 points (1/8 of a full-time year)

The Academic Board has authorised the Academic Deans and Registrars of Colleges in conjunction with the Director of Learning and Teaching and Director of Academic Services to implement these changes to Unit Records and associated publications without further approval.

In amending the Regulations, the following anomalous arrangements regarding credit have been standardised to align with the principle in the Credit Policy which provides for a maximum limit of 50% credit into postgraduate awards.

- a) Master of Theology (Coursework): The current Regulation permits credit of up to 60% of the award. The maximum credit permitted in the Regulation has been reduced to 50%. University of Divinity students who wish to switch from a Graduate Diploma into the MTh and would previously have been eligible for full credit will have the option of handing in Graduate Diploma testamur and transferring units.
- b) Master of Education and Theology: The current Regulation permits credit of up to 44% of the award. The maximum credit permitted in the Regulation has been increased to 50%.
- c) Graduate Certificates (all): The current Regulations permit credit of up to 44% of the award. The maximum credit permitted in the Regulations has been increased to 50%.
