Summary of key activities

- A. Council approved a Graduation Ceremony to be held at 7.30pm on Friday 20 March 2015 at St Michael's Church, Collins Street, Melbourne.
- B. Council approved the schedule of student tuition fees for 2015.
- C. Academic Board approved Determinations to Regulation 3 specifying the awards each College of the University is accredited to offer.
- D. Academic Board approved the formation of a Course Development Panel to ascertain the viability of a professional doctorate, to report to the Board by 30 June 2015.

- 1.1 The following new Regulation was approved by Council on 25 June 2014:
 - a) Regulation 44: Funds Governance
- 1.2 The following amended Regulation was approved by Council on 25 June 2014:
 - a) Regulation 40: Academic Staff, Academic Titles and Honorary Appointments amended to include the title of Visiting Professor. Visiting Professor Nominations Procedures were also approved by Council.
- 1.3 The following Determinations to Regulations were amended by Academic Board on 13 June 2014:
 - a) Determinations to Regulation 3: Accreditation of Existing Colleges: Academic Board approved Determinations to Regulation 3 creating a schedule of the awards each College is accredited to teach, and any conditions on those awards.

- b) Pilgrim Theological College: Academic Board approved a new Determination to Regulation 3 to provide for accreditation of the College to offer awards of the University, subject to signing a Collegiate Agreement.
- c) Diplomas Review Implementation: Determinations to Regulations: Academic Board approved revised Determinations to Regulations 4, 32, 33, 34 and 42 to implement the decisions of the Diplomas Review and to regularise the schedule of credits in undergraduate awards.

- f) Jason Goroncy (Whitley) has been approved to teach at all levels in Systematic Theology and Church History.
