### Summary of key activities

- B. Collegiate Agreements have been signed with the Uniting Church in Australia Synod of Victoria and Tasmania in relation to Pilgrim Theological College and with Trinity College in relation to Trinity College Theological School, to constitute them as Colleges of the University of Divinity from 1 January 2015.
- C. Academic Board approved Trinity College Theological School to teach seven awards of the University.
- D. Council has endorsed a statement of appreciation for the Dalton McCaughey Library, acknowledging the invaluable support of the Society of Jesus and the Uniting Church in Australia through their partnership in constituting the library.

- 1.1 The following amended Regulation was approved by Council on 27 August 2014.
  - a) Regulation 1: General Provisions amended to change custody of the seal and signatories to testamurs, and to remove references to the University of Melbourne and and simplify language in relation to academic dress.
- 1.2 The following Determinations to Regulations were amended by Academic Board on 15 August 2014.

- a) Determination 3.8.7 to Regulation 3: Colleges. Academic Board approved additional awards including several offered in conjunction with Sentir Graduate College of Spiritual Formation.
- b) Trinity College Theological School: Academic Board approved a new Determination 3.8.12 to Regulation 3: Colleges to provide for Trinity to offer seven awards of the University.

  - d) Troy Pittaway (CBC) has been approved to teach the Bachelor-level unit *DM2/3116B Human Rights and Faith: An Introduction*.

- 4.1 Council endorsed the report and recommendations of the self-review of the Human Research Ethics Committee, noted comments from Academic Board, and has commissioned an implementation plan.
- 4.2 Council adopted new Terms of Reference for the Occupational Health and Safety (OVC) Committee.
- 4.3 The University's 2013 HERDC report for research publications and income submitted to the Department of Education showed unweighted publications output at an all-time high of 100.16.
- 4.4 In August the Vice-Chancellor and Director of Administration visited the Head of College or representative of every College of the University to discuss risk management and strategic planning.
