## Summary of key activities

- C. Academic Board approved a definition of divinity, to assist with course accreditation procedures.

d) Determination 33.4.2 to Regulation 33: Diploma in Theology and Determination 34.4.3 to Regulation 34: Advanced Diploma in Theology: Academic Board specified credit for candidates who have completed the Diploma in Ageing and Pastoral Care (91561NSW) from Holy Family Services (RTO 91448) to be granted 60 points in Field D towards the Diploma in Theology, or 120 points of credit in Field D towards the Advanced Diploma in Theology and Ministry.
