### Summary of key activities

- A. A Graduation Ceremony was held on 20 March 2015 in Melbourne, with 409 candidates graduating with awards of the University.
- B. A Graduation Ceremony was held on 5 December 2014 in Adelaide with 42 candidates graduating with awards of the University.
- C. Council approved the 2014 Annual Report including the University's audited financial statements.
- D. The Council received the report and recommendations of the Internal Review of Whitley College and has approved the signing of a Collegiate Agreement for 7 years.
