This Gazette is a public document and is circulated to members of Council, members of Academic Board, Heads of Colleges, and Office of the Vice-Chancellor (OVC) Staff. It reports the outcomes of meetings of the University Council and Academic Board since the last Gazette was issued.

Summary of key activities

- A. 358 students were approved to graduate at a Graduation Ceremony at 7.30pm on Friday 18 March 2016 at St Paul's Cathedral, Melbourne.
- B. The Annual Report 2015 and audited financial statements were approved by the Council, reporting a surplus of \$357,297 for the year.
- C. Council amended the Appeals Policy and Grievances Policy to provide for new arrangements for the management of appeals and grievances processes consequent on the discontinuation of the role of Director of Administration.
- D. The Vice-Chancellor announced the appointments of Mr Ben Roberts (Chief Financial Officer) and Ms Megan Nelson (Events and Communications Manager) in the Office of the Vice-Chancellor.

2. Policies and Procedures

- 2.1 Council approved the Fee Refund Policy which replaces the FEE-HELP Recrediting Policy. This policy provides rules and procedures for the refund of fees, and makes provision for refund of fees in exceptional circumstances after the census date for a unit.
- 2.2 Council approved revisions to the Financial Delegation Policy in light of staff changes in the Office of the Vice-Chancellor and to add the Chief Financial Officer as a signatory to the University's accounts.
- 2.3 Council approved revisions to the Schedule to the Investment Policy to add further options for investment of University funds.
- 2.4 Council approved revisions to the Appeals Policy and Grievances Policy in light of the discontinuation of the role of Director of Administration. Management of appeal and grievance processes has now been delegated to Appeals and Grievances Officers. There are Jit Li Au (Director of Quality and Standards) as primary contact, and Ben Roberts (Chief Financial Officer) as alternate contact. The policy has also been revised to ensure that the manager of a process has no role in determining the outcome.

4. Other matters

- 4.1 The Council approved the 2015 Annual Report and audited financial statements, reporting an operating surplus of \$357,297 for the year. The Annual Report will be available from the University website once it has been tabled in the Victorian Parliament.
- 4.2 The Council received the report of the Vice-Chancellor's Review Committee including the outcomes of the Vice-Chancellor's 2015 performance review and a copy of the Vice-Chancellor's key performance indicators for 2016.
- 4.3 The Academic Board approved 358 students to graduate with 361 awards at the Melbourne Graduation Ceremony to be held at 7.30pm on Friday 18 March 2016 at St Paul's Cathedral.
- 4.4 The Academic Board appointed a Course Development Panel for a Bachelor of Arts to report no later than 9 September 2016, in accordance with Goal 6 in the Strategic Plan, to be chaired by Associate Professor Sean Winter.
- 4.5 The Academic Board approved revised Terms of Reference for the journal *Pacifica*, including a change of name to *Pacifica: Journal of Theological Studies*.
- 4.6 The Office of the Vice-Chancellor initiated a self-review of all University operations against the new Higher Education Standards Framework, to report to the Council through the Governance and Nominations Committee and the Academic Board to ensure full compliance by 1 January 2017.
