This Gazette is a public document and is circulated to members of Council, members of Academic Board, Heads of Colleges, and Office of the Vice-Chancellor (OVC) Staff. It reports the outcomes of meetings of the University Council and Academic Board since the last Gazette was issued.

Summary of key activities

- A. The Melbourne College of Divinity Amendment Bill 2016 was introduced into the Legislative Assembly of the Parliament of Victoria on 7 June 2016. The purpose of the Bill is to amend the title of the institution to the University of Divinity and to make associated changes.
- B. Council approved the University of Divinity Centre for Research in Religion and Social Policy for a period of three years commencing 1 July 2016.
- C. Council approved the student tuition fees for 2017.

1. Regulations and Determinations

- 1.1 The Council made a new Determination to Regulation 18: Centres to establish the University of Divinity Centre for Research in Religion and Social Policy (CRRSP) for a period of three years commencing 1 July 2016. Establishment of this Centre is a Goal in the Strategic Plan, and the Council has now released funds set aside for the Centre to support appointment of a Director.
- 1.2 The Council approved an amendment to Regulation 3: Colleges to change the title of Sentir Graduate College of Spiritual Formation to Jesuit College of Spirituality, subject to approval of the business name.
- 1.3 Academic Board approved an amendment to the Determinations to Regulation 49: Graduate Certificate in Ignatian Spirituality to make minor changes to the course of study.
- 1.4 Academic Board approved amendments to Determination 2.12 (Recognised Institutions) to Regulation 2: General Academic Provisions to provide for recognition of a comprehensive range of overseas institutions for the purposes of admissions and credit.

1.5 Academic Board approved an amendment to Determination 39.3.1 to Regulation 39: Master of Education and Theology to provide for credit and exemption arrangements for students who previously completed study through Australian Lutheran College.

The Bill amends the title of the *Melbourne College* of Divinity Act and the title of the institution to University of Divinity, and makes other consequential changes.
