Note: The Office of the Vice-Chancellor will be closed for the Christmas break from Wednesday 23 December 2020 to Friday 1 January 2021 inclusive. The office will reopen on Monday 4 January 2021.

Summary of key activities

- A. The University has signed a fifteen-year lease with the Franciscan Order of Friars Minor for a part of the St Paschal's, 90 Albion Road, Box Hill property, comprising the northern and western wings. The Office of the Vice-Chancellor is expected to relocate from Kew to St Paschal's in May 2021, along with the School of Graduate Research, Indigenous Studies Centre, and Professional Supervision Program.
- **B.** Emeritus Professor Gabrielle McMullen has been reappointed Deputy Chancellor of the University by Council for a term of three years commencing 1 January 2021 and concluding 31 December 2023.
- **C.** Professor David Starling and Professor Mary Coloe were appointed Professors of the University by Council on 2 December 2020.
- **D.** Reverend Associate Professor Graham Hill has been appointed as Principal of Stirling Theological College with effect from 1 December 2020.
- **E.** 71 students receiving 73 awards graduated at the online Graduation Ceremony held via Zoom on 4 December, with 10 of 11 Colleges represented.
- **F.** The Council has approved the University's revised Strategic Plan 2025: *Growing in Partnership*.

- **1.1** On 2 December 2020, Council made the following amendments to Regulations and Determinations to Regulations:
- 1.1.1 Regulation 1 General Provisions: The Schedule (formerly Determinations) has been substantially revised to dissolve the Strategic Planning and Human Research Ethics Committees, and to establish the Research Strategy Committee (reporting to the University Executive). Changes have also been made to the membership requirements and Terms of Reference for other committees. HREC services for the University from 2021 will be provided through a partnership with the Christian Research Association.

- 1.1.2 Regulation 3 Colleges: The Regulation and its Determinations have been updated to remove Jesuit College of Spirituality as a College of the University with effect from 1 January 2021.
- **1.2** On 6 November 2020, the Academic Board made the following amendments to Determinations to Regulations:
- 1.2.1 Regulation 2 Academic Board: The Determinations have been updated to dissolve the Research Committee and establish a School of Graduate Research Committee.
- 1.2.2 Regulations 7, 9, 22 and 38 (HDR awards): Consequential amendments have been made to the Determinations to reflect the changes in research governance (per 1.2.1)
- 1.2.3 Regulation 85 Advanced Diploma in Counselling: Determination 85.2.5 has been updated to replace RQ2930S Academic Research and Writing with the modified unit DP1930S Academic Research and Writing.
- 1.2.4 Regulation 78 Master of Counselling: Determination 78.2.4.1 has been updated to replace DP9779S Critical Incident Counselling, Trauma and Suicide with DP9079S Critical Incident Counselling and Care.
