Summary of key activities

- A. The University's Annual Report for 2021, incorporating the audited financial statements for 2021, was approved by Council on 9 March 2022 for submission to the Parliament of Victoria. The report will be available from the University website after it has been tabled in Parliament on 3 May 2022.
- **B.** Professor Albert Haddad has been appointed as Dean of Academic Programs and Professor of Higher Education. He will commence in this role on 28 March 2022.
- C. In February, Dr Graeme Blackman AO marked 10 years as Chancellor of the University of Divinity. In honour of this occasion, Council has moved to name the St Paschal Estate boardroom the Dr Graeme L Blackman AO Room.
- **D.** The University will hold a graduation ceremony at 7.30pm on Friday 25 March, at St Paul's Anglican Cathedral, Melbourne.
